

## Result 2: The Farm4SD - Modular Training Course

Based on the "Methodological Framework", that was published in March, and aims **to improve the capacity of VET institutions and trainers to understand farmers' needs**, the Result 2: Farm4SD Modular Training Course was developed.





The course consists of four modules, addressing EU farmers. Each module has been divided into face-to-face training, self-directed learning (asynchronous) and synchronous online training.

The pillars of Sustainable Agriculture

The learners will get introduced to the European pillars of sustainable agriculture in Europe: The Agenda 2030, the European Green Deal, the Farm to Fork Strategy, the Biodiversity Strategy, and the new CAP. Furthermore, they will get to know the basics of sustainable agriculture and adjusted farming management practices. They will gain the ability to critically reflect on the sustainable agricultural sector, considering its social,

ecological, and economic aspects, enhance value chains and processes, adapt to market dynamics, and embrace both tradition and innovation in the sector.

Entrepreneurial Skills for the Sustainable Farmer

At the end of the module, the learners will have gained the knowledge and skills to be able to develop a sustainable long-term business strategy.

## Financial literacy and funding for the Green Transformation

The learners will be able to act as financially literate entrepreneurs, ensuring that their agricultural businesses can last over the long term, by **applying** the basic principles of managing finance and identifying public and private sources of funding.

Essential Soft Skills for the Sustainable Farmers

At the end of the module, the learners will be able to apply soft skills such as communication, critical thinking, teamwork, creativity, agility, and networking that are essential for acting as entrepreneurs, thus ensuring the long-term viability of their agricultural business.

After the completion of the pilot trainings in each partner country, farmers will be able to access an electronically sealed certificate or acquire micro-credentials, having the form of European Credentials for Learning.

## TPM in Poland and LTTA in Slovenia



On 25.05.23, the third transnational partner meeting (TPM) took place in a hybrid form. We managed to push forward on the project results and establish common decisions for the next steps. The meeting gave us new motivation for the next months, and we are already looking forward to seeing each other again at the next partner meeting in Greece, in the coming year in January.

Before our next transnational meeting, we have yet another get-together that is planned for September 2023: The Joined Staff Training Activity (LTTA). The Farm4SD LTTA has the aim to bring together vocational educators/trainers, and staff or associates of the partner organizations in order to reskill and upskill on: the pillars of the sustainable agriculture;, on key competences regarding agriculture entrepreneurship; and

funding opportunities. The aforementioned topics are covered in the four (4) modules of the Result 3-Traine-the-Trainers Program for VET Educators, which we have developed over the last months, aiming at preparing the VET trainers to support farmers in their sustainable transition. Further, we want to recap on advanced VET learning methods and techniques and the implementation of the updated ECVET, ECTS and Micro-credential approach in validating the newly acquired qualifications.

In addition, there are some further **next steps**, we want to highlight: Within the next weeks, we will finish Result 3, and exploit it during the LTTA. Moreover, we are working on Result 4 - Farm4SD Multifunctional and Interactive Platform. *The platform will be populated with the developed learning materials, that will be freely available in English, French, German, Greek, Polish and Slovenian*.
